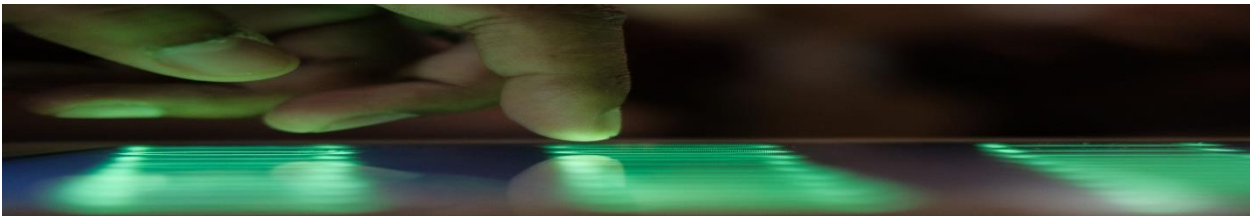
**Safety & Security**

The properties will be remodeled in a luxury style appearance that will give three floor levels a different appearance of office, dining, spa and salon, includes but not limited to, a neighboring lot and community center to introduce activities, such as food services, aquaponic greenhouse and fish farming. The project is expected to take place next year in 2022, and while we are working with a law firm, the group is dedicated to the meeting grounds located in Pittsburgh, PA where we are able to address issues and planning, helping us to perform such methods of contracting and construction by a suspected date proposed for spring of next year. At a time like this, expectations leads one to feel a critical necessity for leading companies and umbrellas to bring forth unity efforts to present the major discomforts early.
